

## FAQ: DataTribe Challenge 2023

**Q:** What is the DataTribe Challenge?

**A:** The DataTribe Challenge is a challenge to identify technology startups with a vision to disrupt cybersecurity and data science.

Q: What do the finalists receive from DataTribe?

**A:** Three finalists will split \$20,000 in prize money, and one may receive up to \$2 million in seed capital from DataTribe.

**Q:** What is required of contestants?

Q: How do I apply for the challenge?

**A:** Submit your application and all required materials to: <u>https://datatribe.com/challenge/</u>.

Q: What dates do I need to know?

A: Contestants have until **September 23rd** to apply at <u>https://datatribe.com/challenge/</u>. DataTribe will review submissions for technical merit, market potential, and readiness of the team. On **October 12th**, DataTribe will publicly announce up to three finalists. These teams will then have until **November 1st** to refine their pitches and prepare for final judging, with assistance from DataTribe's team of startup veterans. The finalists will present their startups and answer questions from judges on **November 2nd**.

**Q:** How much time do I need to plan spending at DataTribe?

A: There will be in-person practice and a dress rehearsal at DataTribe on November
1st. The event itself will be on November 2nd. You should plan on spending both days at DataTribe. We will provide a work space for you to be productive during your visit.
